Fivehead and Swell Parish Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

This website is partially compliant with the <u>Web Content Accessibility Guidelines version 2.1</u> AA standard, due to the non-compliances listed below.

Non accessible content

The content listed below is non-accessible for the following reasons:

- All documents that have to be scanned in because it is not possible to make these PDFs accessible
 by a screen reader because they are images, so there is no plan to fix them.
- Documents provided by third-parties because we cannot control the format of these documents as we are not the authors. It is not possible to fix these documents.
- Historical documents because it is not possible to make these PDFs accessible by a screen reader because they are images.
- The accessibility regulations don't require us to fix PDFs or other documents published before 23

 September 2018 if they're not essential to providing our services. Some of our older PDFs and Word documents don't meet accessibility standards for example, they may not be structured so they're

accessible to a screen reader. This doesn't meet WCAG 2.1 success criterion 4.1.2 (name, role value).

Accepting the points above, we intend to investigate and resolve, where possible, the issues below by September 2020:

- The use of tables by the search box fails WCAG 2.1 success criterion 1.3.6 (identify purpose).
 Generated table code may not be HTML5 compliant
- Some headings may not cascade inside some features on some web pages
- Some pages may contain the same or limited link text going to different pages, some link text referring to the same page may require consistency
- Whilst the website has been developed using plain English there is a need to improve consistency
 across the site including use of consistent and accessible dates and times and remove characters
 that are difficult to be read
- Some images may have duplicate alternative text or have no alternative text

Any new PDFs or Word documents we publish will meet accessibility standards.

Disproportionate Burden

The website is new, built by Town & Parish Councils Websites, and the framework complies with WCAG 2.1 AA. We feel that by having a new compliant framework website built and making as many PDF documents readable by a screen reader, that we have done all that we possibly can do. The Parish Council also considered the numbers of visitors who accessed the website (statistics held by the Webmaster). This information helped the Council decide that further work on the accessibility requirements would impose a Disproportionate Burden on the Council.
